- Special Rules:**
- Up to 25 commercial/for-profit entries will be chosen for the parade with priority given to entries that feature a strong patriotic, artistic or entertaining element and local Murray businesses. A detailed description, drawing or photo of the entry is strongly encouraged for the selection process.
 - Political entries are limited to 10 walkers and 1 vehicle (# of vehicle riders limited to number of available seating).
 - All for-profit business/commercial applications and the \$100 entry fee must be submitted by **JUNE 3, 2016** and selected by **June 13, 2016**. Those entries that are not selected will be refunded the entry fee.
 - NO application will be accepted after **June 10, 2016** —subject to a \$20 late fee.
