### **DIRECTOR'S REPORT**

Kim shared that the Park Impact Fee will go to Council on October 3<sup>rd</sup>. He would like a member or members of the Parks and Recreation Board to be present to answer any questions regarding the Boards decision to impose the full amount that was calculated by Zion's Bank.

All positions within the Recreation Department have been filled. Joe Gourley has been hired as the Park Center Assistant Director and Tasha LaRocco has been hired as a Recreation Coordinator. The Parks Department has an open position for Maintenance Worker that is open to both internal and external applicants.

Salt Lake County voted to reinstate TRCC (Tourism, Recreation, Culture & Convention) funding for the Murray Theater that was withdrawn due to COVID. If passed by Salt Lake City Council, Murray will be receiving back the original 3.5 million dollars it was granted to fund the Murray Theater renovation.

The Golf Course is still waiting on a delivery of golf carts. A shortage of parts has delayed the production. The Parks Department will begin resealing the entire Murray section of the Jordan River Parkway trail this week. This project will take a couple of months to complete.

The Facilities Department has been working on numerous roof repairs and leaks on nearly all buildings from the recent storms. All current repairs will be complete this week. Fortunately, we did not see much tree damage.

The Recreation Department will be having their annual Pumpkin Races on October 11<sup>th</sup> from 5:30pm-7pm at Constitution Circle. Murray Park Lane will be closed to traffic during this event.
