

The Board of Trustees of the MBA (Municipal Building Authority) of Murray City, Utah, met electronically at 4:30 p.m. on Tuesday, June 15, 2021. Public Notice was hereby given that the meeting would occur without an anchor location in accordance with Utah Code 52-4-207(4) due to infectious disease COVID-19 Novel Coronavirus.

President Cox called the meeting to order at 4:30 p.m. and welcomed all in attendance.

Public Hearing: Consider a resolution adopting the final budget for the Municipal Building Authority of Murray City for Fiscal Year 2021 – 2022. (See Attachment)

- Ms. Moore presented the Fiscal Year 2021 – 2022 tentative MBA budget that included the allocation of approximately \$20 million to fund the construction of the new city building. She noted that bond interest would be paid in December 2021 and the original bond was \$34 million. Remaining proceeds would be rolled forward after the closing of FY 2020-2021.

President Cox called for a motion on the item: Ms. Turner motioned to approve the resolution to adopt the final budget for the Municipal Building Authority of Murray City for Fiscal Year 2021 – 2022. Mr. Hales seconded. Passed 4-0.
