Call to Order: President Hock began the meeting at 6:25 p.m.

Approval of Minutes: Municipal Building Authority Meeting, January 7, 2025. Ms. Cotter moved to approve the minutes and Mr. Pickett seconded the motion. All in favor 5-0.

Business Item:

- **Consider a resolution adopting the tentative budget of the Municipal Building Authority of Murray City, as amended, for the Fiscal Year beginning July 1, 2025, and ending June 30, 2026; giving notice and scheduling a public hearing to receive public comment before the final budget is adopted.** Finance Director Brenda Moore highlighted three transactions of the tentative MBA (Municipal Building Authority) budget. Ms. Moore said the MBA would first receive from other City funds a total of \$3.1 million for rent, which would be applied to the debt service for constructing the new city hall building. Second, the MBA would allocate \$16 million for the public works reconstruction project; and third, make the debt service payment of \$3.1 million on city hall bonds.

Ms. Moore confirmed that currently the only activity of the MBA was to fund the public works project and receive and pay debt payments on city hall. Ms. Moore noted all total debt for both the new city hall and the public works project. She pointed out that the 2026 debt service payment for city hall was \$1.8 million and for the public works project, which was waiting to begin, the 2026 debt service payment was \$1.2 million. The public hearing date for adopting the final MBA budget would be set for June 17, 2025.

MOTION: Mr. Pickett motioned to approve the resolution, and Mr. Goodman SECONDED the motion.
