### NOTICE OF PUBLIC HEARING

Notice is hereby given that on February 16, 2016, beginning at 6:30 p.m. of said day in the Council Chambers of the Murray City Center, 5025 South State Street, Murray, Utah, the Murray City Municipal Council will hold and conduct a Public Hearing on and pertaining to the following proposed amendments to the Fiscal Year 2015-2016 Budget:

1. Increase the General Fund by \$77,754 from Beer Tax Revenue and appropriate \$77,754 for police alcohol enforcement.
2. Increase the General Fund by \$60,000 from the General Fund Reserves and appropriate \$60,000 to pay for Macquarie Milestone One.
3. Transfer \$58,000 from the Perpetual Care Fund to Capital Projects Fund and appropriate \$58,000 from the Capital Projects Fund to fund the Cemetery Road Project.
4. Increase the General Fund by \$68,586 from Public Employee Health Plans (PEHP) dividend payment and appropriate \$68,586 to allocate PEHP dividend payment to employees.
5. Increase the Library Fund by \$2,711 from PEHP dividend payment and appropriate \$2,711 to allocate PEHP dividend payment to employees.
6. Increase the Water Fund by \$4,338 from PEHP dividend payment and appropriate \$4,338 to allocate PEHP dividend payment to employees.
7. Increase the Waste Water Fund by \$2,169 from PEHP dividend payment and appropriate \$2,169 to allocate PEHP dividend payment to employees.
8. Increase the Power Fund by \$11,657 from PEHP dividend payment and appropriate \$11,657 to allocate PEHP dividend payment to employees.
9. Increase the Parkway Golf Fund by \$1,898 from PEHP dividend payment and appropriate \$1,898 to allocate PEHP dividend payment to employees.
10. Increase the Solid Waste Fund by \$272 from PEHP dividend payment and appropriate \$272 to allocate PEHP dividend payment to employees.
11. Increase the Storm Water Fund by \$2,169 from PEHP dividend payment and appropriate \$2,169 to allocate PEHP dividend payment to employees.

12. Increase the Fleet Fund by \$814 from PEHP dividend payment and appropriate \$814 to allocate PEHP dividend payment to employees.

13. Increase the Retained Risk by \$543 from PEHP dividend payment and appropriate \$543 to allocate PEHP dividend payment to employees.

The purpose of the hearing is to receive public comment concerning the proposed amendments to the City's 2015-2016 Fiscal Year Budget.
