Alexandra Efrano, 3735 Judd Circle, West Jordan, Utah

Ms. Efrano stated that she applauds Murray City for building and staffing the Senior Center, they cook the best lunches in the world. However, she has a complaint against staff members of the Heritage Center: There is a sign in the bridge room saying “no profanity, and keep things pleasant”. There are people at the center, who take the Lords name in vain, over and over again. Ms. Efrano has complained to staff members, but feels that her complaints are not taken seriously. She was told to “just walk away” from it, but as she has walked away from the bridge games, there were complaints issued against her, and she was suspended. When she asked staff the specifics of the suspension, she feels that she was assaulted by the staff, when the grabbed her arm and she fell, although not hurting herself. She has spoken to the Public Services Director about the incident, and feels that he condoned the assault, and she is here to say this is not right.

Richard Welch, Scout Leader 932 W. Walden Meadows Dr, Murray

Mr. Welch stated that the Boy Scout oath says that they will do their duty to God and our Country, and they have a reverence; our founding fathers said ‘the battle cry of the Republic was: we will have no king, but king Jesus. We sit as a congregation this day, because of the liberties provided by our founding fathers.’ He would never stand for irreverence to the God of this land, and would hope that other people would learn the integrity that made our nation what it is. He would hope that they could understand what it means to be a bearer of truth.
